What is the overall <u>deductible</u> ?	<b>\$0</b> at Indian Health Care Providers (IHCP) or with IHCP referral at non-IHCP; or <b>\$3,000</b> individual / <b>\$6,000</b> family	Generally, you must pay all the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , office visits, certain lab tests, certain <u>prescription drugs</u> , and <u>urgent care</u> services are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . Are there other <u>deductibles</u> for specific services?	No. There are no other specific deductibles.	You don't have to meet <u>deductibles</u> for specific services, but see the chart starting on page 2 for other costs for services your plan covers.
What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	For In-Network providers: <b>\$7,000</b> individual / <b>\$14,000</b> family. Pediatric Dental is limited to <b>\$350</b> per child or <b>\$700</b> for 2 or more children.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the out-of-pocket limit?	Premiums, prescription drug brand additional charges and manufacturer assistance, and services this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket</u> <u>limit</u> .
Will you pay less if you use a <u>network provider</u> ?	Yes. See <b>www.avmed.org or call 1-800-477-8768</b> for a list of IHCP and AvMed In-Network providers.	You pay the least if you use an IHCP. You pay more if you use a <b><u>provider</u></b> in the AvMed Network. You will pay the most if you use an out-of-network provider, and you might receive a bill from a <b><u>provider</u></b> for the difference between the <b><u>provider's</u></b> charge and what your <b><u>plan</u></b> pays ( <u><b>balance billing</b></u> ). Be aware your <u><b>network provider</b></u> might use an out-of-network provider for some services (such as lab work). Check with your <u><b>provider</b></u> before you get services.
Do you need a <u>referral</u> to see a <u>specialist</u> ?	Yes.	This <u>plan</u> will pay some or all of the costs to see a <u>specialist</u> for covered services but only if you have a <u>referral</u> before you see the <u>specialist</u> .
