Important Questions	Answers	Why This Matters:
What is the overall deductible ?	\$0 at Indian Health Care Providers (IHCP) or with IHCP referral at non-IHCP; or \$0 individual / \$0 family	Generally, you must pay all the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. This plan has no medical deductible .	This plan covers some items and services even if you haven't yet met the deductible amount.
Are there other deductibles for specific services?	Yes. \$3,500 individual / \$7,000 family for prescription drugs . There are no other specific deductibles .	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services.
What is the out-of-pocket limit for this plan ?	For In-Network providers: \$8,350 individual / \$16,700 family. Pediatric Dental is limited to \$350 per child or \$700 for 2 or more children.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums, prescription drug brand additional charges and manufacturer assistance, and services this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. See www.avmed.org or call 1-800-477-8768 for a list of IHCP and AvMed In-Network providers.	You pay the least if you use an IHCP. You pay more if you use a provider in the AvMed Network. You will pay the most if you use an out-of-network provider, and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.
Do you need a referral to see a specialist ?	Yes.	This plan will pay some or all of the costs to see a specialist for covered services but only if you have a referral before you see the specialist .

Does this plan provide Minimum Essential Coverage? Yes.
