This is a summary of health and drug services covered by AvMed Medicare Choice.

AvMed Medicare Choice is a Medicare Advantage HMO plan with a Medicare contract. Enrollment in the plan depends on contract renewal. The benefit information provided does not list every service that we cover or list every limitation or exclusion. To get a complete list of services we cover, please request the *Evidence of Coverage* (EOC) or you may view the EOC online at <http://www.avmed.org>.

To join AvMed Medicare Choice, you must be entitled to Medicare Part A, be enrolled in Medicare Part B, and live in our service area. Our service area includes the following county in Florida: Miami-Dade.

As a member you must select an in-network doctor to act as your Primary Care Provider (PCP). Except in emergency situations, if you use providers that are not in our network, we will not pay for these services. Also, if you use pharmacies that are not in our network to obtain prescription drugs, the plan may not pay for those drugs.

You may visit <http://www.avmed.org> to search for a network provider or pharmacy using the online directories. You can also view the Plan Drug List (Formulary) to see what drugs are covered, and if there are any restrictions.
