Urgent	<ul> <li>Members will be triaged which involves identifying those which can be managed in the office or through alternative resources. Members requiring emergent care, (defined as life- threatening) will be granted immediate access or offered Emergency Room as an alternative if after hours or the cannot be safely managed in the office setting. Members in need of Urgent Care (Sudden or recent onset of symptoms that need prompt medical attention) will be seen in the office, by first available practitioner in a group.
